Rotary Club Scholarship Requirements

1. To be eligible, the student must rank in the top 1/3 of his class.
2. The student must graduate during this school year.
3. Student must intend to attend a college-level school, starting this year, with the intention of earning a degree or professional certificate.
4. Student must show a strong history of, and potential for continuing, community service.
